## SCOPE AND CONTENT NOTE

The collection consists of bar docket books from the DeWitt County Circuit Court, dating from 1873-1911, with the bulk before 1896. Docket books cover three annual terms; March, August, and December. From 1873-1896, the Honorable Lyman Lacey was the primary judge for the court, with Cyrus Epler, A.G. Burr, and G.W. Herdman also filling the role. State's attorneys include Stephen K. Carter, William R. Kelly, William H. Booth, and John Fuller, among others.

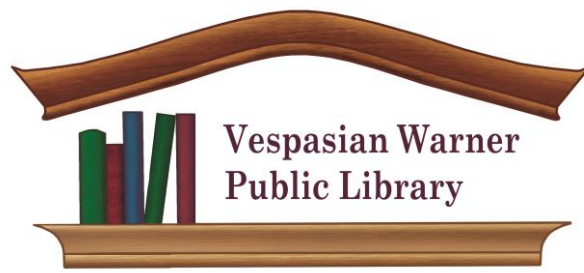

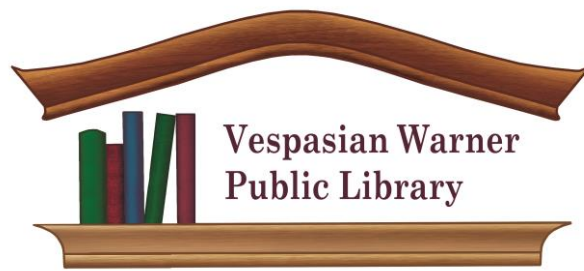

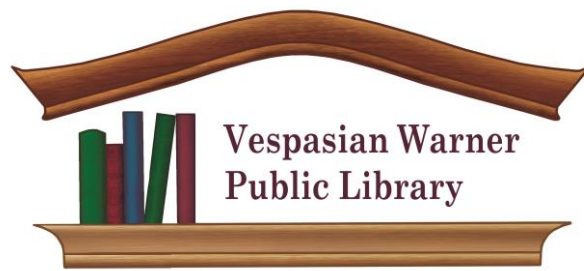
